



Sliding Fee Discount Schedule
Effective April 1, 2018

The APLA Health & Wellness sliding fee discount schedule is used to determine the discount a patient will receive on their total charges for services. The scale below is based on monthly income. These fees and discounts apply to medical, dental and behavioral health services provided directly by APLA Health & Wellness.
