A Letter From Our Leadership

Like many organizations, APLA Health continues to navigate numerous challenges as the COVID pandemic slowly transitions to endemic status. Our patients and clients have been impacted along with the communities we serve, but our APLA Health team members have consistently stepped up to meet the need during these unprecedented times.

Despite these obstacles, our overall outlook remains optimistic. Over the last two years, APLA Health has opened two brand new, state-of-the-art Federally Qualified Health Centers and significantly expanded our existing stand-alone dental clinic.

Also during this time, the Alliance for Housing & Healing (AHH) became a subsidiary of APLA Health. AHH is a leader in the “housing first” model of healthcare and is the largest provider of housing and housing support services for people living with HIV in Los Angeles County. When combined with APLA Health’s Vance North Necessities of Life Program, the nation’s largest food pantry program for people living with HIV, APLA Health has become an award-

winning national example of the vital importance of comprehensively addressing social determinants of health to ensure that we end HIV.

Lastly, APLA Health undertook an intensive year and a half process of creating and adopting a new Five-Year Strategic Plan through consultation with the Board of Directors, input from staff leadership and the full staff, guidance from local health and philanthropy leaders, and reflections from sister organizations with similar target populations and roles. The resulting plan identifies six overarching priorities with related strategies, which subsequently led to an update of our organization’s mission statement: “APLA Health restores dignity and trust within underserved communities by providing world-class LGBTQ+ empowering healthcare, support services, and HIV specialty care.”

Thanks to your continued support, on the following pages you’ll read about the real efforts we have made, and continue to make, to ensure that all members of our community have access to culturally competent healthcare.

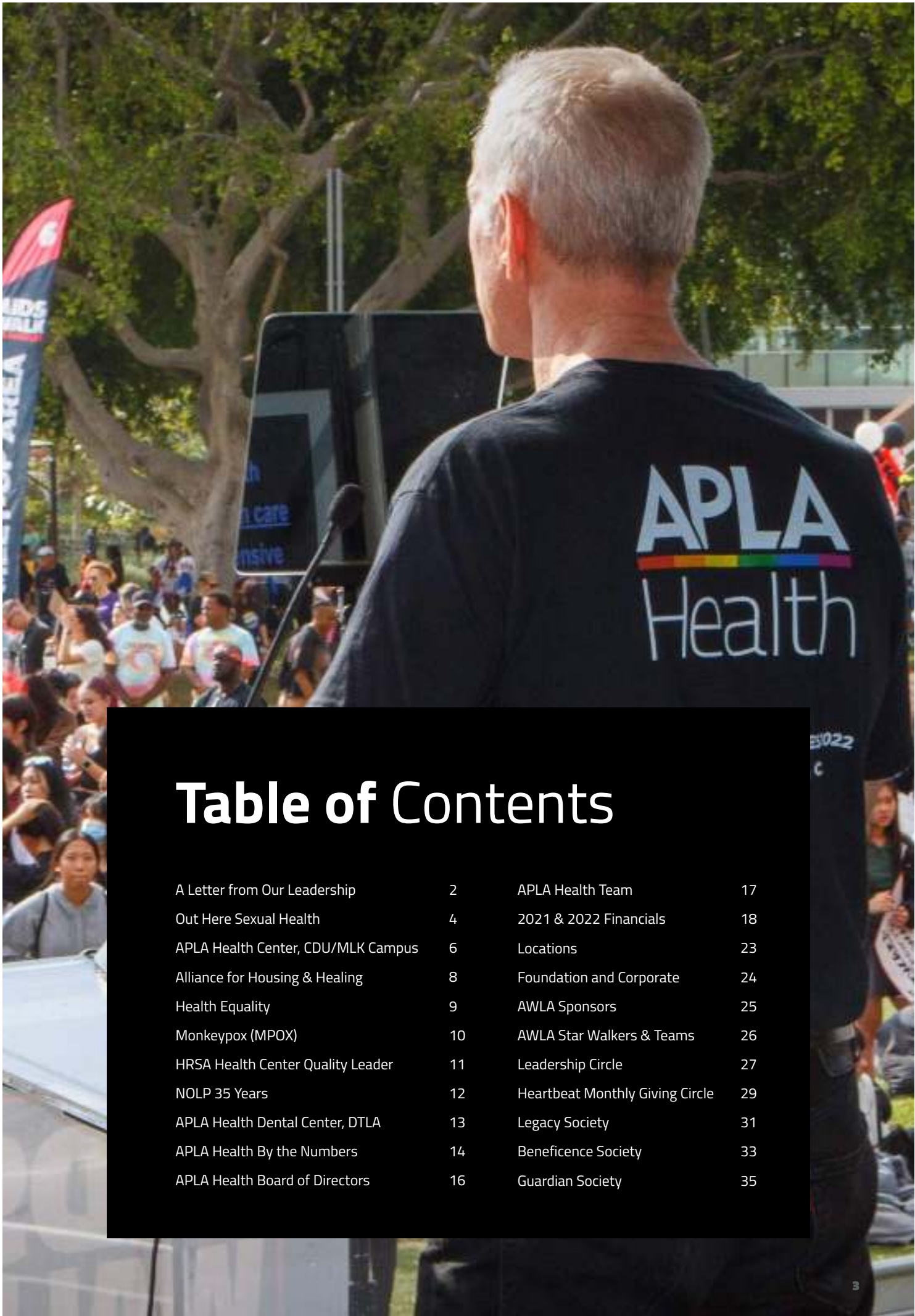

Out Here Sexual Health

In 2022, APLA Health introduced *Out Here*, a new sexual health brand that reimagines how we deliver testing, treatment, and prevention services.

The Out Here Sexual Health Center, Baldwin Hills opened in April 2022 as the first APLA Health center dedicated exclusively to this new brand.

Featuring six exam rooms, this facility offers low/no cost expedited HIV testing, STD screening/treatment, PrEP, PEP, and community resources with linkage to over 100 services and programs offered throughout LA County.

With Out Here's low/no cost sexual health services, extended service hours, and same-day online appointments, APLA Health has worked diligently to expand access to those in greatest need by creating a culturally competent, sex positive environment in which we seek to eliminate barriers and shame for those seeking and reaching care.

APLA Health Center, CDU/MLK Medical Campus



In July 2022, APLA Health opened our 8th Federally Qualified Health Center (FQHC) site in Los Angeles County. APLA Health Center, CDU/MLK Medical Campus is located on the campus of Charles R. Drew University, one of only four historically Black medical schools in the United States, and directly across the street from the Martin Luther King Jr. Community Hospital (MLKCH) in South Los Angeles.

This new location provides LGBTQ+ primary medical, dental, and behavioral healthcare. It also houses one of our Vance North Necessities of Life Program food pantries. This is also the first APLA Health Center to offer our Out Here Sexual Health Services alongside our traditional APLA Health branded healthcare services.



APLA Health has been in this part of South Los Angeles serving the needs of the surrounding communities of Watts, Compton, Lynwood, South Gate, and Willowbrook since 2001. The residents of this area lack access to community-based providers (South LA has a deficit of 1,300 doctors), the rate of diabetes in South LA is 3x higher than the rest of the state, diabetes mortality is 72% higher, and life expectancy is 10 years shorter. In light of these severe health disparities, APLA Health has responded by making its largest financial investment in a health center facility to date!

This new location provides LGBTQ+ primary medical, dental, and behavioral healthcare. It also houses one of our Vance North Necessities of Life Program food pantries. This is also the first APLA Health Center to offer our Out Here Sexual Health Services alongside our traditional APLA Health branded healthcare services. This means patients at this site can make same-day appointments online and complete their intake forms electronically in advance for HIV testing, STD screening/treatment, and PrEP & PEP.





Alliance for Housing & Healing

powered by APLA Health

Founded in 1983, Alliance for Housing & Healing (AHH) is the largest provider of housing, support services and financial assistance for people living with HIV/AIDS and their families in LA County. Resulting from the merger of The Serra Project and Aid For AIDS (AFA), AHH is a leader in the “housing first” model of healthcare and widely known for promoting housing stability, improving health outcomes and boosting HIV medical compliance. Over 1,200 people with HIV and their families are served by AHH on an annual basis.

Since the merger, APLA Health has consolidated all of its housing support services under the AHH banner. AHH’s housing expertise combined with APLA Health’s Vance North Necessities of Life Program food pantries and other support services will ensure that people living with HIV/AIDS have comprehensive services to directly address their social determinants of health. Combining our expertise and strategic resources will allow us to build a world-class program that broadly and capably serves the needs of people living with HIV/AIDS in LA County.

Healthcare Equality Index

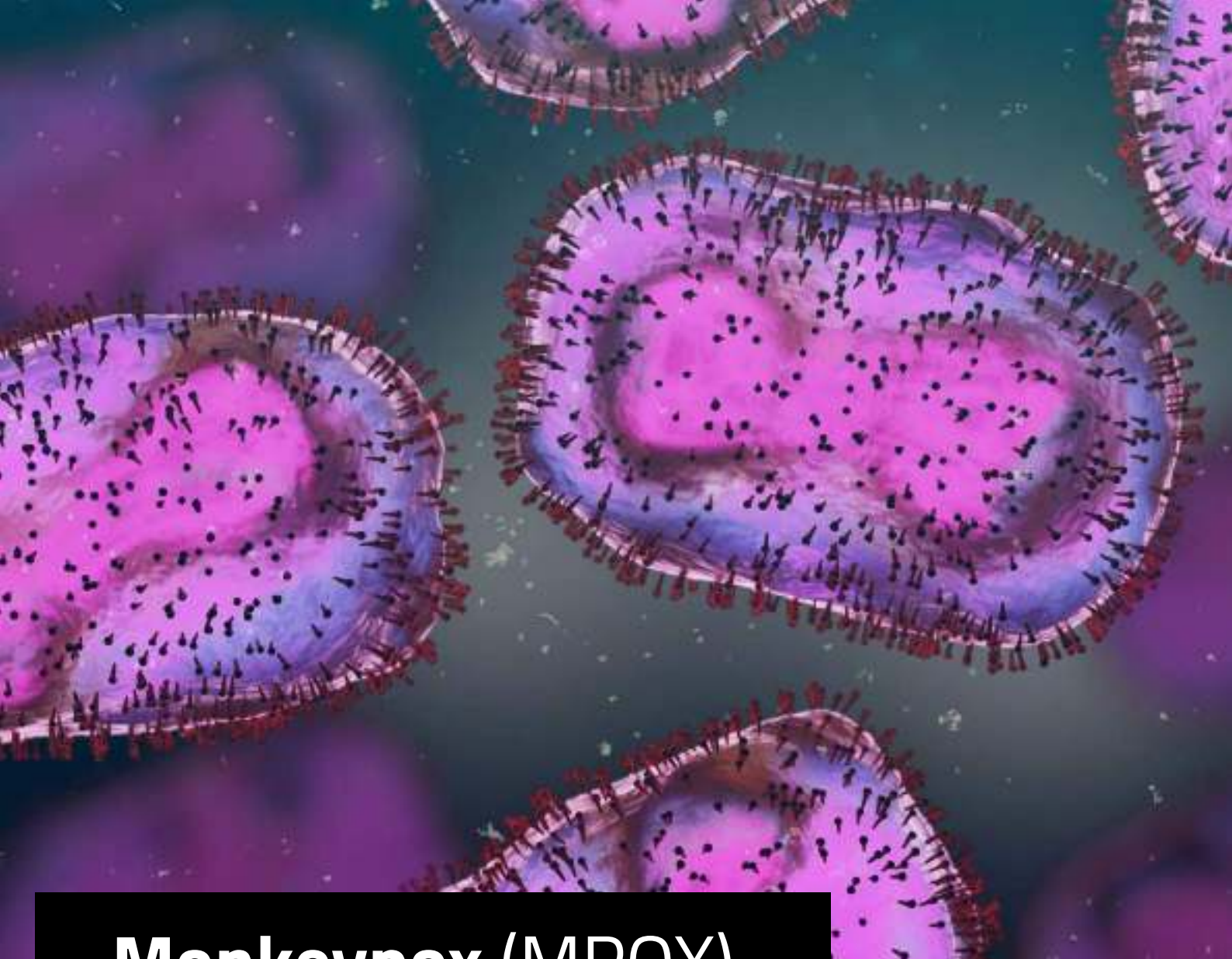
In April 2022, APLA Health was awarded a perfect 100 score on the Human Rights Campaign (HRC) Foundation's 2022 Healthcare Equality Index (HEI), resulting in the coveted "LGBTQ+ Healthcare Equality Leader" designation.

In its 15th year, a record 906 healthcare facilities actively participated in this national LGBTQ+ benchmarking survey of healthcare facilities on policies and practices dedicated to the equitable treatment and inclusion of their LGBTQ+ patients, visitors and employees.

HEI participants are scored on how many LGBTQ+ inclusive policies and practices they have in place across four different criteria: Foundational elements of LGBTQ+ patient-centered care, patient services and support, employee benefits and policies, and patient and community

engagement. In addition, participants have to demonstrate that they offer transgender-inclusive healthcare benefits to their employees to receive the "LGBTQ+ Healthcare Equality Leader" designation.





Monkeypox (MPOX)

In June 2022, APLA Health leaped into action on the frontlines of the global MPOX outbreak by providing LA County's LGBTQ+ community with desperately needed education and resources, testing, vaccination, and treatment.

To date, APLA Health has administered over 4,000 MPOX vaccine doses and remains committed to vaccinating as many of our patients and community members as possible. Our medical providers have diagnosed numerous patients with MPOX and helped to ensure they have access to high-quality care and treatment—including TPOXX.

APLA Health also successfully led a group of 50+ organizations in securing additional funding and resources to address the MPOX outbreak in California from Governor Newsom and the state legislature.



HRSA Health Center Quality Leader, Gold Level



Of the four awards earned by APLA Health, Health Center Quality Leader, Gold Level, is the most significant. The highest level of this award, Gold Level is only awarded to the top 10 percent of health centers nationwide. This is the third consecutive time APLA Health has received this award.

HRSA provides Quality Improvement Awards to recognize the highest performing health centers nationwide and further its commitment to improving the overall quality, efficiency, and value of healthcare services for the more than 30 million patients served at health centers across the United States.

In 2022, the U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), announced APLA Health had received four Quality Improvement Awards for its work as a federally qualified health center.





APLA Health Dental Center, Downtown Los Angeles

In August 2021, APLA Health unveiled its expanded and remodeled dedicated dental facility in Downtown Los Angeles.

Four new treatment rooms were added to the site (for a total of 12). Also, for the first time, APLA Health is now able to offer specialty dental services with the addition of an endodontic microscope (essential to root canal therapy) and a cone beam CT/panoramic X-ray machine (needed for both advanced oral surgery and endodontics) at this site. This is the largest of four APLA Health sites in Los Angeles County that offer dental services.

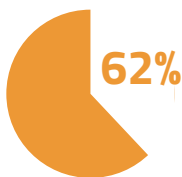

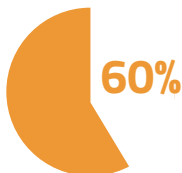
