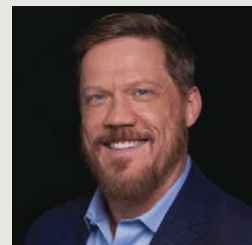

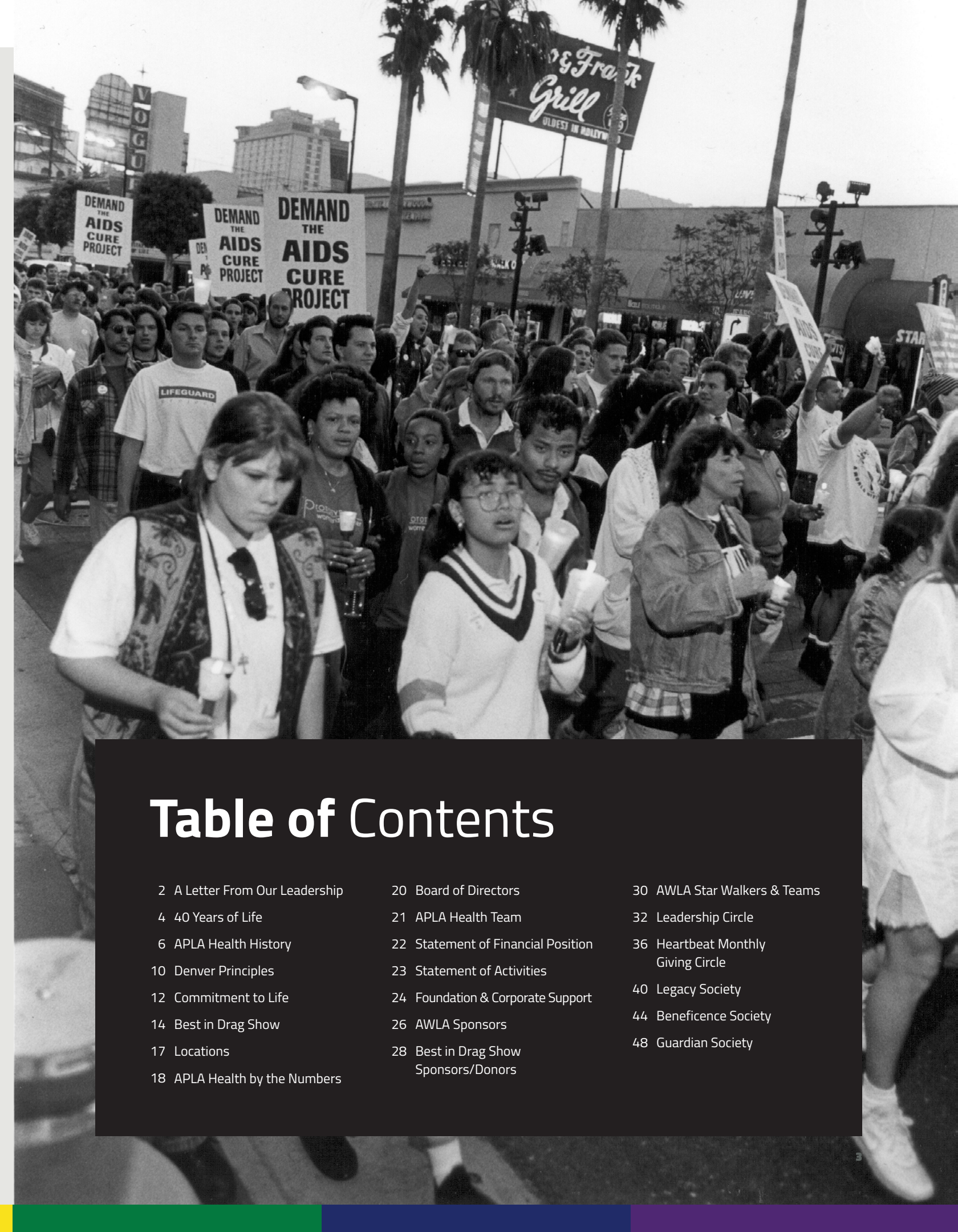

40 Years of Life

APLA Health Commemorates “40 Years of Life” in Los Angeles County

APLA Health (formerly known as AIDS Project Los Angeles) celebrated our 40th anniversary in 2023, reflecting on four decades of compassionate care and service, under the theme “40 Years of Life”.

On January 14, 1983, Nancy Cole Sawaya, Matt Redman, Ervin Munro, and Max Drew officially founded the agency with the election of its first board of directors. Our humble origins were born from a group of concerned citizens who took quick and decisive action in response to a mysterious disease.

Originally operating out of a closet at the Gay and Lesbian Community Services Center, the agency’s first service was a single-line, volunteer staffed information and referral hotline. As the devastation of the AIDS crisis rapidly increased, the agency expanded its offerings to include comprehensive HIV support services, HIV testing and prevention education, and government advocacy.

Forty years later, APLA Health is recognized as a Gold Level, HRSA Health Center Quality Leader, with seven Federally Qualified Health Center (FQHC) sites throughout Los Angeles County serving over 18,000 patients and clients. We provide over 20 different services including: medical, dental, and behavioral healthcare; HIV specialty care; sexual health services; and community resources. For people living with HIV, we offer housing support services through the Alliance for Housing & Healing, benefits counseling, home healthcare, and the Vance North Necessities of Life Program food pantry program.

As we look to the future, APLA Health will build upon its foundation of compassionate service and legacy of resilience to build a future where every person can live with dignity, health, and opportunity.

APLA Health History

For forty 40 years, APLA Health has played an active role in supporting people with HIV/AIDS and the greater LGBTQ+ community in Los Angeles, whether in the form of treatment, education, support, or policy. This is our story.

1983

AIDS Project Los Angeles (APLA) founded by Nancy Cole Sawaya, Matt Redman, Ervin Munro, and Max Drew. Originally operating out of a closet at the Gay and Lesbian Community Services Center, the agency's first service was a single-line, volunteer staffed information and referral hotline (AIDS Hotline) followed by a Hospital Buddy Program.

Aid for AIDS (AFA) founded by a group of friends in the greater Hollywood area to help others in the community devastated by AIDS. By providing emergency rent, mortgage, and utility payments, AFA allowed people to die with dignity in their own homes.



1984

APLA establishes a Housing Services division.

1985

APLA Dental Clinic founded to treat people living with AIDS who were denied services by other dentists.

APLA holds the world's first AIDS Walk Los Angeles event at Paramount Studios with a goal of \$100,000. Instead more than 4,500 walkers raised \$673,000.

APLA throws first "Commitment to Life" gala and raises \$1.3 million with Elizabeth Taylor as host.



1986

The Necessities of Life Program (NOLP) launches as a \$35 food voucher program to provide food to people suffering from HIV/AIDS.

APLA establishes a Government Affairs Division. Its goals were to increase state and local resources for AIDS prevention, education and care, as well as to promote fair and humane HIV/AIDS legislation.



1987

The Serra Project founded under the sponsorship of seven major Los Angeles County hospitals and the Catholic Archdiocese in response to the growing number of people left homeless by their battle with acute HIV/AIDS.

1988

The Serra Project opens their first group home in the City of Los Angeles. Later state licensed as a Residential Care Facility for the Chronically Ill (RCFCI).

1989

The first iteration of “Best in Drag Show” (known then as “Battle for the Tiara”) launched as a privately organized event with funds benefiting Aid for AIDS.

1993

Aid for AIDS partners with the City of West Hollywood to unveil the West Hollywood AIDS Memorial Walk on Santa Monica Boulevard between Fairfax Avenue and Doheny Drive. Bronze plaques pay tribute to lives lost to HIV/AIDS.

2000

APLA Dental Clinic moves to Good Samaritan Hospital in downtown Los Angeles.

2001

APLA relocates David Geffen Center to 611 South Kingsley Drive in Mid-City.

2002

Additional NOLP sites open in South Los Angeles and Long Beach.

2006

APLA's International Programs consolidated into Global Forum on MSM & HIV (MSMGF).

2009

S. Mark Taper Foundation Dental Clinic and NOLP site opened on Martin Luther King Jr.—Charles Drew University campus in South Los Angeles.

Aid for AIDS merges with the Serra Project to create Alliance for Housing & Healing (AHH).

2011

APLA Health & Wellness Center opened in Baldwin Hills for HIV prevention services.



2013

APLA Health & Wellness Center services expanded to include HIV testing and STD screening & treatment.

APLA Health & Wellness receives New Access Point Grant and designation as a Federally Qualified Health Center (FQHC).

2014

Global Forum on MSM & HIV (MSMGF) separates from APLA and becomes its own 501(c)3 nonprofit organization, with APLA continuing to provide administrative support services.

Gleicher/Chen Health Center opens in Baldwin Hills, becoming APLA Health's first FQHC site.

2015

APLA Health & Wellness Health Education site opens in Baldwin Hills.

2016

APLA Health Center, Long Beach opens—our second FQHC site.

2017

APLA Health Board approves acquisition of Global Healthcare LA, which becomes APLA Health Center, Mid-Wilshire.

2018

AIDS Project Los Angeles merges into APLA Health & Wellness.

The Global Forum on MSM and HIV (MSMGF) changes its name to MPact: Global Action for Gay Men's Health and Rights.

HIV-Elders (HIVE) program created for men with HIV 50 years of age and older to improve their health and well-being by addressing stigma, social isolation, social support, connection, and empowerment.

2019

Dr. Michael Gottlieb moves his private practice to APLA Health Center, Mid-Wilshire.



2021

Alliance for Housing & Healing becomes a subsidiary of APLA Health & Wellness.

APLA Health Dental Center, Downtown Los Angeles remodels and expands with four new treatment rooms (12 total) and introduces specialty dental care services.

2022

APLA Health opens the Out Here Sexual Health Center, Baldwin Hills, funded in part by LA County as a part of its new Sexual Health Express program.

APLA Health opens the APLA Health Center, Charles Drew University/Martin Luther King Jr. Medical Campus.

2023

“Commitment to Life” documentary, directed by Emmy Award-winning director Jeffrey Schwarz, has its world premiere at the Santa Barbara International Film Festival.

MPACT and APLA Health conclude their partnership.

Alliance for Housing & Healing fully merges with APLA Health & Wellness.

“Commitment to Life” documentary makes its worldwide streaming debut to the public on World AIDS Day.



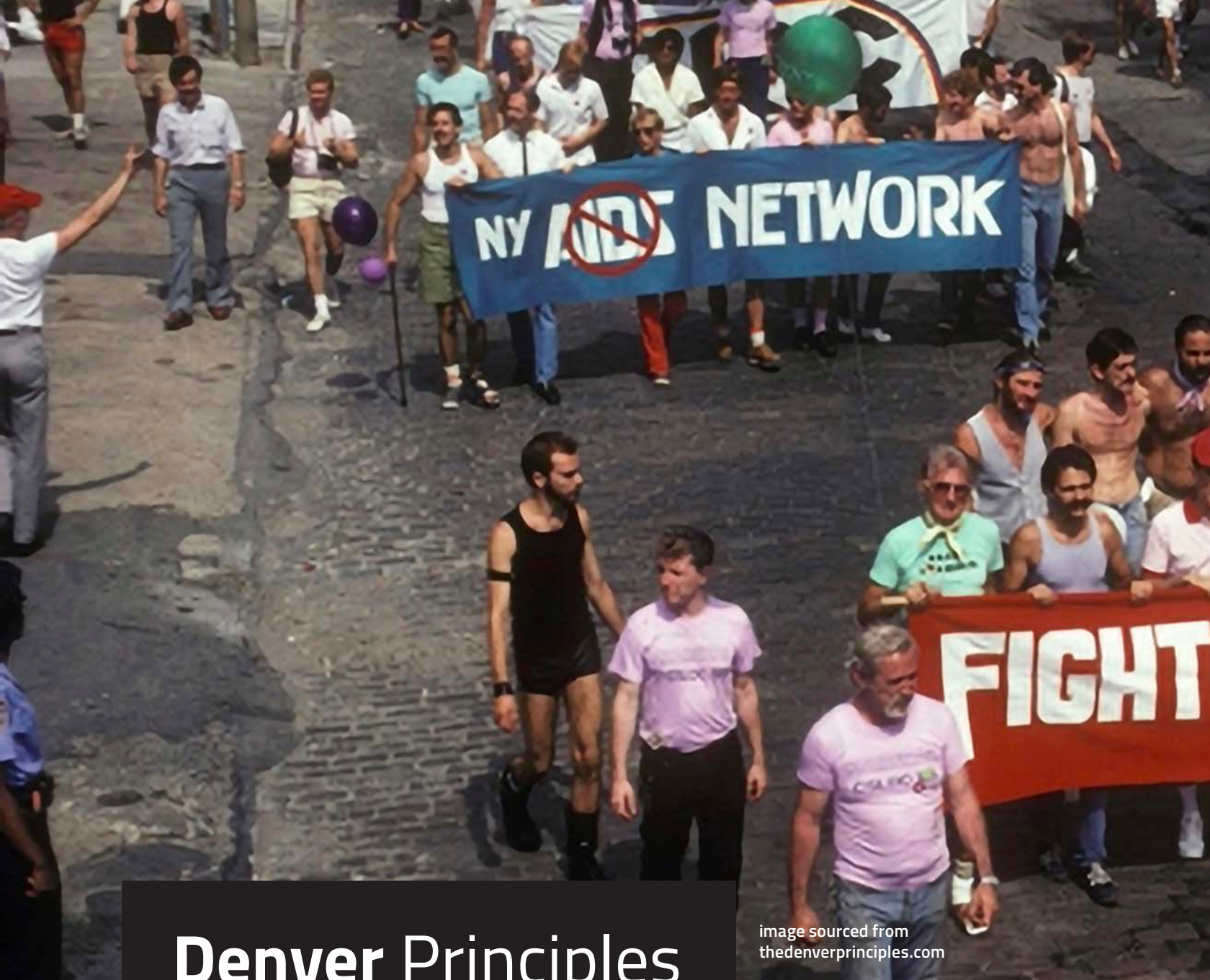

Denver Principles

2023 marks the 40th anniversary of the development of the Denver Principles—one of the most significant events in HIV/AIDS history. The Denver Principles not only asserted the rights of people living with HIV/AIDS, they had far-reaching implications in the future for anyone living with any kind of disease or disorder.

In June 1983, at a lesbian and gay health conference in Denver about a dozen gay men with AIDS representing the nascent AIDS movements on the

east and west coast convened. The conference's theme was prescient: "Health Pioneering in the Eighties." These early activists developed a novel set of principles including recommendations for all people, recommendations for people with AIDS, and a statement of rights for people with AIDS. Their declaration, known as the Denver Principles, articulated ground rules and an ethos for People with AIDS (PWA).



For individuals facing a novel, catastrophic illness like AIDS, the notion that people could live with this disease rather than passively die from it was a decisive reframe away from acquiescence to empowerment and agency. The concept disrupted convention. It was also irresistible as it immediately resonated with others. People facing cancer or other life-threatening or chronic conditions quickly found empowerment by embracing this self-understanding.

THE DENVER PRINCIPLES

Statement from the Advisory Committee of People with AIDS

We condemn attempts to label us as "victims," a term which implies defeat, and we are only occasionally "patients," a term which implies passivity, helplessness, and dependence upon the care of others. We are "People With AIDS."

RECOMMENDATIONS FOR HEALTH CARE PROFESSIONALS

1. Come out, especially to their patients who have AIDS.
2. Always clearly identify and discuss the theory they favor as to the cause of AIDS, since this bias affects the treatments and advice they give.
3. Get in touch with their feelings (e.g., fears, anxieties, hopes, etc.) about AIDS and not simply deal with AIDS intellectually.
4. Take a thorough personal inventory and identify and examine their own agendas around AIDS.
5. Treat People with AIDS as whole people, and address psychosocial issues as well as biophysical ones.
6. Address the question of sexuality in people with AIDS specifically, sensitively and with information about gay male sexuality in general, and the sexuality of people with AIDS in particular.

RECOMMENDATIONS FOR ALL PEOPLE

1. Support us in our struggle against those who would fire us from our jobs, evict us from our homes, refuse to touch us or separate us from our loved ones, our community or our peers, since available evidence does not support the view that AIDS can be spread by casual, social contact.
2. Not scapegoat people with AIDS, blame us for the epidemic or generalize about our lifestyles.

RECOMMENDATIONS FOR PEOPLE WITH AIDS

1. Form caucuses to choose their own representatives, to deal with the media, to choose their own agenda and to plan their own strategies.
2. Be involved at every level of decision-making and specifically serve on the boards of directors of provider organizations.
3. Be included in all AIDS forums with equal credibility as other participants, to share their own experiences and knowledge.

Commitment to Life

To celebrate the future, it's important to commemorate the past. APLA Health unveiled its feature-length documentary, "Commitment to Life," with Emmy Award-winning director, Jeffrey Schwarz, to chronicle the true story of the fight against HIV/AIDS in Los Angeles.

"Commitment to Life" chronicles the evolution of the AIDS epidemic in Los Angeles and the community response, led by APLA Health. With no federal support for the AIDS crisis until 1992, a full ten years into the epidemic, each major city had to develop a robust, localized response to address the fear and suffering in their respective communities.

AIDS advocates across America mobilized the unique resources available to them. In Los Angeles, we had possibly the most influential resource of

all—Hollywood. APLA had the honor and privilege of partnering with some of the most influential entertainment executives and celebrities in the world, including David Geffen, Jeffrey Katzenberg, and Elizabeth Taylor, among others. "Commitment to Life" documents how APLA Health used its resources to lead the response in Los Angeles from the beginning of the epidemic and how it evolved to address the current needs of the County's underserved populations.



"Commitment to Life" made its world premiere on February 11, 2023, at the Santa Barbara International Film Festival. On July 15, the film made its public debut in Los Angeles at the Outfest Film Festival. More than 500 people attended a screening at the Director's Guild Theater, followed by a lively panel discussion with some of the creative forces that brought the film to life.

Damien Navarro, Executive Director of Outfest, and Craig E. Thompson, CEO of APLA Health, introduced the film, using their personal stories and histories to underscore the importance of the role that Los Angeles and AIDS Project Los Angeles played in the early fight against HIV/AIDS.

The documentary was screened at over 50 film festivals worldwide, winning Best Feature Documentary at the Long Beach QFilm Festival, and Director's Choice and Festival Favorite at Cinema Diverse: The Palm Springs LGBTQ Film Festival.

Subsequently, NBCUniversal acquired the rights to the film. It debuted on its subscription streaming service, Peacock, on December 1, 2023 (World AIDS Day).

"Commitment to Life" is executive produced by former APLA Health Board Member Ron Sylvester and the team at Automat Pictures, led by Jeffrey Schwarz, Producer/Director, and Aimee Flaherty, Producer.

From its humble beginnings in a West Hollywood living room to its current home at the Orpheum Theatre, the fundraiser's impact has always been far-reaching, touching the lives of countless individuals over the last several decades and raising millions of dollars to support the vital work of Alliance for Housing & Healing. Since joining



forces with APLA Health in 2021, AHH continues in its mission to support low-income people with HIV/AIDS through stable housing and food assistance.

As the curtain rises on another unforgettable evening of laughter, love, and liberation, Best in Drag Show continues to remind us that when we come together as a community, there's no limit to what we can achieve.

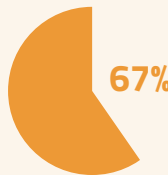
